

DELAC Minutes  
4-25-19

DELAC meeting was called to order at 10:42a.m. by Mrs. Priscilla Herrera.

Approval of Agenda and Minutes: Ms. Irma Huerta made a motion to approve and the motion was seconded by Ms. Maria Molina.

AU Report:

- Mrs. Herrera reported the following overview of the ELAC meetings at AU
  - 8 ELAC meetings held (1x per month) both in afternoons and evenings. Dinner was provided at evening meetings and this helped gain participation
  - Agendas were provided at each meeting
  - Ms. Herrera gave an overview of meeting topics

For WFEC and WUHS, no report was provided. WUHS struggled this year to form a functional committee.

Migrant Calendar was provided; a correction will be made for Oct. 20th.

Mrs. Herrera facilitated a discussion of ELAC calendar coordination between the sites.

Mrs. Herrera thanked the Hmong community representatives and parents for coming to the DELAC meeting and for participating in ELAC.

DELAC Secretary:

- Decision was made to vote on a new DELAC secretary at the next meeting held in the 19-20 school year.

Go Public Schools Fresno:

- Mrs. Herrera presented on her experience at the Go Public Schools Fresno training. She attended a training on how to hold a successful parent meeting and recommended that WUSD host a similar training. After a group discussion, it was agreed that a parent/committee member training should be provided for WUSD parents. It was suggested that topics could include representing parent groups, increasing participation, and Roberts Rules of Order. The group agreed to look into providing a training in Sept. of the 19-20 school year for parent representatives.

LCAP Presentation for Final Approval by Mrs. Troxell.

- Mrs. Troxell reviewed the Budget overview for Parents and LCAP draft and asked for comments/discussion. It was discussed that the BOP was drafted using interim budget numbers and that the final budget would be completed in May/June.
- The group approved of the BOP and draft.

Adult Education Presentation by Mr. Thor:

- Mr. Thor re-capped the adult program offerings from 18-19 and talked about Summer and Fall course options.
- The group brought up a problem with communication from the adult school to parents who signed up for the Spring ESL courses. Mr. Thor reviewed the process and assured parents that multiple phone calls were made to all parents who signed up. The adult school keeps records of all phone calls and other communication to parents.
- Mrs. Herrera thanked the secretaries on behalf of the DELAC for their hard work in organizing the Adult Education program sign-ups.

College and Career Day Invitation from Mrs. Xiong:

- Mrs. Xiong from WFMS gave an invitation to the first annual College and Career fair at WFEC. It will be held May 1st and parents and community members are invited from 9:30-10:15a.m.
